ARTICLES OF INCORPORATION  
OF

A Florida Professional Corporation

We, the undersigned, all of whom are duly licensed to practice mental health counseling in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I – CORPORATE NAME AND MAILING ADDRESS

The name of the Corporation shall be:

CHRISTIAN FAMILY COUNSEL P.A.

ARTICLE II – DURATION

This corporation shall exist perpetually, commencing as of January 1, 2000 with the filing of these Articles of Incorporation by the office of the Secretary of State of the State of Florida.

ARTICLE III – PURPOSE

The Corporation is organized for the purpose of engaging in the practice of mental health counseling within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

ARTICLE IV – CAPITAL STOCK

The corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

## ARTICLE VI – INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially; the number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one (1). ## ARTICLE VIII – RESTRICTIONS ON THE SALE OF STOCK

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholders or to this Corporation. The price and terms at which, and the time within which, such shares may be offered and sold shall be further specified by written agreement among all of the shareholders of this Corporation.

## ARTICLE IX – ADOPTION OF BYLAWS

A special meeting of the scribes or their assigns shall be held, upon the call of the president, for the purpose of completing the organization of the corporation and the adoption of the Bylaws and the transaction of such other business as may come before the meeting.

## ARTICLE X – AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholder is subject to this reservation.

## ARTICLE XI – TERMS OF ISSUING STOCK

Stock to be issued pursuant to these Articles of Incorporation shall be issued under the terms, provisions and conditions of Section 1244 of the Internal Revenue Code.

## ARTICLE XII – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock or authorized but unissued stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE XIII – INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

## ARTICLE XIV – PROFESSIONAL SERVICES

The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice mental health counseling within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by this Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or practice rules of mental health counseling.


