The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: **McKELLUM INVESTMENT GROUP, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 649 West Thompson Street, Lake City, Florida 32055.

ARTICLE III. CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is Fifty Thousand (50,000) shares of one class of Common Stock, having a par value of One Dollar (\$1.00) per share

ARTICLE IV. PURPOSE

The purpose for which this corporation is organized is to engage in all lawful business activity permitted under the laws of the United States of America and the State of Florida.

ARTICLE V. DURATION

The period of duration of the corporation shall be perpetual.
