The name of the corporation shall be **Skylane Management, Inc.**

ARTICLE II NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

The name and address of the initial director of the corporation is **Philip Tuccelli of 393 Woodlake Lane, Deerfield Beach, Florida 33442.**

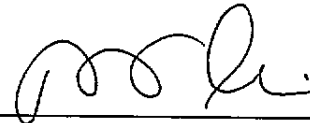
ARTICLE IX

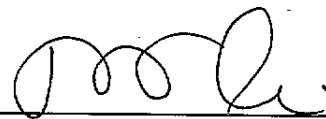
