ARTICLE I - NAME

The name of this corporation is CENTER FOR PLASTIC SURGERY, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of the corporation is 1501 Forest Hill Boulevard, West Palm Beach, Florida 33406.

ARTICLE III - DURATION

This corporation shall exist perpetually commencing as of the date these Articles are filed with the Secretary of State's office.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of providing surgical services and all other lawful business.

ARTICLE V - CAPITAL STOCK

The Corporation shall have the authority to issue One Thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

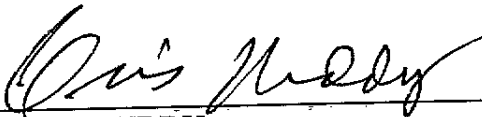

ARTICLE X - INDEMNIFICATION

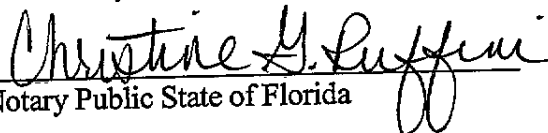

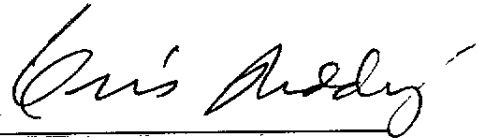
