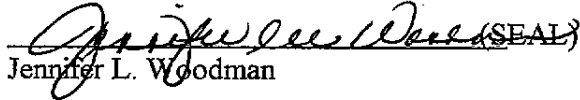
ARTICLE VI

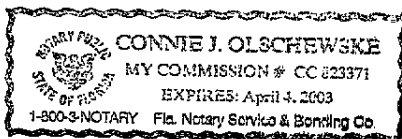
