The name of this corporation is PAPARELOS & SONS, INC.

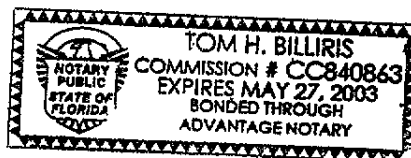


