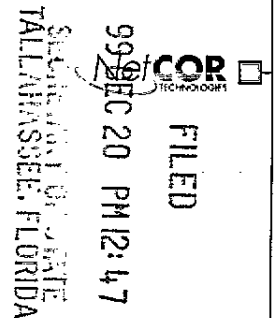

- FIRST: The name of this corporation is **BOCA RATON OPERA INC.**
- SECOND: **Boca Raton Opera Inc.** is organized for the purpose of transacting any lawful business for which corporations may be formed in Florida.



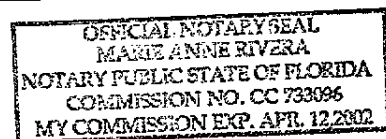


