ARTICLES OF INCORPORATION

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

ARTICLE I

Name of Corporation

The name of this Corporation shall be Sharoubim Three, Inc. (the "Corporation").

ARTICLE II

Mailing Address

The mailing address of the Corporation is 1 South County Road, Palm Beach, FL 33480.

ARTICLE III

Purpose

This Corporation is organized for the following purposes:
