ARTICLE I. NAME

The name of this corporation shall be Christel S. Martin, P.A.



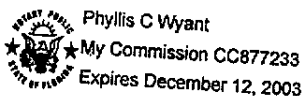
