ARTICLE I. NAME

The name of this corporation shall be Jerry L. Beach, P.A.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on January 1, 2000.



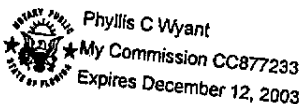
