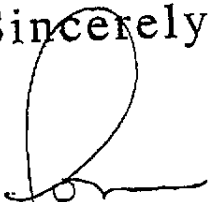

Articles of Incorporation of AAA Insurance Advisors, Inc.

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

Article I - Name

The name of the corporation is: AAA Insurance Advisors, Inc.

Article II - Duration

The corporation shall have perpetual existence.

Article III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated in the State of Florida.

Article IV - Capital Stock

The corporation is authorized to issue shares of ten cents (\$.10) par value common stock.

Article V - Initial Registered Office and Agent

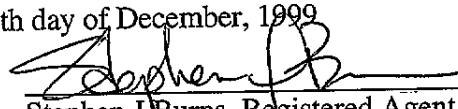
