#### ARTICLES OF INCORPORATION

OF

#### HAIL MARY GROWERS, INC.

The undersigned, acting as incorporator of a corporation under the laws of Florida, adopts the following Articles of Incorporation for such corporation.

## ARTICLE I

The name of this corporation is HAIL MARY GROWERS, INC.

## ARTICLE II

- A. This Corporation is organized for the purpose of to own and operate a business to develop, grow, purchase and sell at wholesale and retail longans and other tropical fruit. To do any and all necessary and incidental acts in connection with the orchard or farming business.
  - B. To do any and all legal business.
