

Articles number six (6) and number (7) of the Articles Incorporation of Lucky 7 #6, Inc., is amended by the corporations incorporator on May 26, 2000. Shareholder option was not required. The Corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to Florida Statutes 607.682 now therefore;

1. The name of the corporation is Lucky 7 #6, Inc.

2. Article six (6) of the Articles of Incorporation of Lucky 7 #6, Inc. was amended to read as follows:


