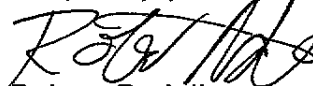

The undersigned incorporator, for the purposes of forming a private corporation for profit under the Florida Business Corporation Act, hereby acknowledges and files the following Articles of Incorporation.

ARTICLE I.

Name and Address of Principal Office

The name of the corporation is Go Extreme Network.com, Inc., and the principal office of the corporation is currently located at 6503 N. Military Trail, unit #1800, Boca Raton, Florida 33496.

ARTICLE II.

Duration

The corporation shall commence existence on the date of the execution and acknowledgment of these Articles if permitted by law; if not, then on the date of filing. This corporation shall exist perpetually thereafter, unless sooner dissolved according to law.

ARTICLE III.

Common and Preferred Stock

This corporation is authorized to issue 10,000,000 (ten million) shares of stock with a par value of .001, of which 5,000,000 (five million) shall be classified as common stock, and 5,000,000 (five million) shall be classified as Class A preferred, Class B preferred and Class C preferred.

ARTICLE IX

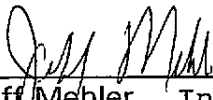
Working Capital
