ARTICLES OF INCORPORATION
of
Reuter Accounting & Tax Service, Inc.

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of the corporation is:

REUTER ACCOUNTING & TAX SERVICE, INC.

ARTICLE 2 MAILING ADDRESS

ARTICLE 3 DURATION

The duration of the Corporation is perpetual.

ARTICLE 4 PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.**
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.**

ARTICLE 5 CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a \$1.00 par value.

ARTICLE 6 INITIAL REGISTERED OFFICE AND AGENT

In accordance with Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of execution by the incorporator of these Articles of Incorporation. In the event these Articles of Incorporation are not filed within the time period set forth in Section 607.0203, Florida Statutes, the date when corporate existence shall commence is the date of filing by the Secretary of State.
