The undersigned, acting as the sole incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND ADDRESS

The name of the corporation is Master Plumbing Systems, Inc. The address of the corporation is 4587 25th Court SW, Naples, Florida 34116.

ARTICLE II

DURATION
