This corporation is a new corporation formed in 1999. The owners Christopher and Rebecca Hamilton are new business owners and have never owned a corporation before. While they formed their corporation in 1999, their establishment did not open for business until early 2000. This restaurant is located at a newly remodeled marina that had not previously had a separate business operating out of its facilities. During such time there was confusion with the Post Office concerning the delivery of mail. The uniform business report for this taxpayer was put in a mailbox that was subsequently flooded. (Note the severe discoloration-and-staining). Thetaxpayer did not find this form until after the due date for filing.
