
Additionally, we request abatement of the late filing fees based upon reasonable cause as explained below.

This corporation is a new corporation formed in 1999. The owners Christopher and Rebecca Hamilton are new business owners and have never owned a corporation before. While they formed their corporation in 1999, their establishment did not open for business until early 2000. This restaurant is located at a newly remodeled marina that had not previously had a separate business operating out of its facilities. During such time there was confusion with the Post Office concerning the delivery of mail. The uniform business report for this taxpayer was put in a mailbox that was subsequently flooded. (Note the severe discoloration and staining). The taxpayer did not find this form until after the due date for filing. As this is the first year the Corporation is required to file a Uniform Business Report, the taxpayer was unaware of the filing requirements until such time as additional correspondence was received and the "flooded form" was located.

The late filing of this report was not due to any intentional disregard for the rules and regulations regarding such filings. The taxpayers are now aware of the filing requirements and have initiated internal procedures to insure that all forms such as this are filed in a timely period in the future.
