Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **VIEW TECHNOLOGIES, INC.** (the "Corporation"), **Charter # P99000111665**, filed on December 29, 1999.

2. The following Amendment to the Articles of Incorporation was adopted by the sole Director of the Corporation without Shareholder action as there has not been any shares issued, in the manner prescribed by Section 607.1005 of the Act on January 31, 2000.

RESOLVED, that Article I of the Corporation's Articles of Incorporation shall be amended in its entirety to read as follows:
