ARTICLE I

Name

The name of the corporation is **HYPERGATE.COM, INC., a Florida corporation**

ARTICLE II

Principal Office

Each holder of a Class A Common Stock, as such, shall be entitled to one vote for each share of Class A Common Stock held of record by such holder on any and all matters on which stockholders generally are entitled to vote. Except as otherwise required by law, each holder of a Class B Common Stock, as such, shall not be entitled to any vote for any share of Class B Common Stock held of record by such holder on any and all matters on which stockholders generally are entitled to vote.
