ARTICLES OF INCORPORATION

SORE 23 MILLION

OF

BOSWELL INVESTMENTS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation;

ARTICLE I

ARTICLE V


