

Dear Mr. Toner,

I am in receipt of your letter dated November 15, 2000; in which you stated that the only way to waive the reinstatement fee of \$750.00 is if my company did not receive the uniform business report notice. In your letter you used the words "previous" as if I were responding to that notice. As I said in my letter to you on October 19, the only correspondence I received from your Department since I incorporated was the notice of dissolution of my corporation. The only document I was told I had to file since I have been incorporated was from the Department of Treasury. They asked me to file a form 941 in April, a form 1120 in March 2001 and form 940 in Jan 2001. Therefore, can I again request a waiver of the reinstatement fees? If not, what are the procedures to just incorporate the company again. It is certainly cheaper.
