ARTICLE I NAME

The name of this corporation is **JET ENTERPRISES OF BREVARD, INC.**

ARTICLE II DURATION

This corporation shall exist perpetually commencing as of the date of execution and acknowledgement of these Articles.

ARTICLE III PURPOSE

This corporation is organized for the purpose of conducting any lawful business.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with each share having a par value of \$1.00 per share.

IX BYLAWS

ARTICLE XII POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE XIII DIRECTOR QUORUM AND VOTING

A majority of the directors shall constitute a quorum for a meeting of directors.

If a quorum is present, the affirmative vote of a majority of the directors present shall be the act of the Board of Directors.

ARTICLE XIV AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
