

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

PARSONS AND ASSOCIATES
ATTORNEYS AT LAW, P.A.

The address of the principal office of this corporation shall be 1853 Victoria Avenue, Fort Myers, Florida 33901 and the mailing address of the corporation shall be P.O. Box 2462, Fort Myers, Florida 33902.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities associated with the practice of law in the State of Florida.

- A. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation.
- B. To own property, enter into contracts and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
