ARTICLE I

<u>NAME</u>

The name of this corporation shall be RAB SERVICES, INC.

ARTICLE II DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV CAPTIAL STOCK
