ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE ONE: NAME

The name of this corporation is CARNEY ENTERPRISES, INC.

ARTICLE TWO: NATURE OF BUSINESS

This corporation is being formed for the purpose of providing transportation services for import, export, and domestic; and further to exercise all those powers granted by Law, including but not limited to the following:
