ARTICLE 1- NAME

The name of this corporation is **RAMY N. FARES, P.A.**

ARTICLE 11- DURATION

This corporation shall have perpetual existence commencing JANUARY 1, 2000.

ARTICLE 111- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as an attorney.


