ARTICLES OF INCORPORATION

OF

D A F LAND COMPANY

ARTICLE - I

The name of this corporation is: **D A F LAND COMPANY.**

ARTICLE - II

The purpose of this corporation is to own, manage and operate a commercial land fill business and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock

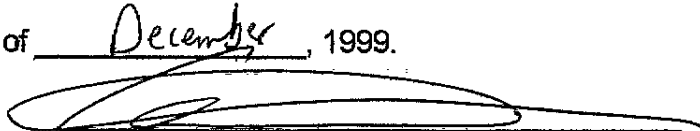
ARTICLE VIII - BYLAWS

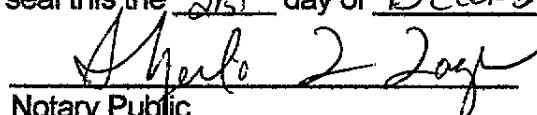

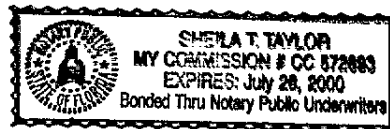

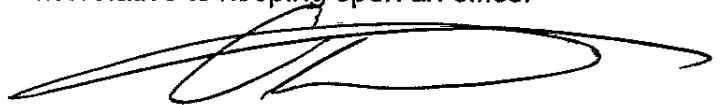
