Dear Madam,

We have included a revised application. Our attorney filed another designation of registered agent that is identical in substance, if not in fact, to this one just a few weeks ago. Your department accepted that filing. I sent my attorney your letter, and he says he has no clue why you rejected our submittal yet accepted the other he filed. Please reference document number Q15000000090. Aside from the names and addresses, this document is identical to our filing. If your office accepted one but rejected the other, can you please tell us what is different about our filing that leads you to this adverse determination? Because no one on our legal team can make any sense of your finding. Florida State Statute 607.0505 clearly states that any entity (including trusts) that are 10% or more owned by a foreign person MUST file as an Alien Business Organization with a registered agent in Florida. This is exactly the nature of our filing as well as document Q15000000090, which your office accepted without issue! Can you please clarify for us the nature of your rejection? If you reconsider your determination, please process our registration using the version included in this transmittal. Thank you for your time.
