

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopted the following articles of amendment to its articles of incorporation, filed September 17, 1990, number S00711.

First: Article IV, Capital Stock paragraph numbered 1 shall be amended to read as follows:

1. Number and Class of Shares Authorized; Par Value. The capital stock authorized, the par value thereof and the class of said stock shall be as follows:

Number of shares Authorized	Par Value Per Share	Class of Stock
1,000,000	\$1.00	common

The consideration for all the above stock shall be payable in cash, property (tangible and intangible), labor or services, in lieu of cash: all at adjust valuation to be fixed by the Board of Directors of the Corporation.

SECOND: The date of the amendment's adoption: April 12, 1997.

The amendment of Article IV, paragraph 1 above was adopted by unanimous consent of the Board of Directors and all of the Stockholders at a joint meeting of the Board of Directors and Stockholders held on the 12th day of April, 1997 at 2:00 p.m. at the offices of the corporation.
