
Enclosed is the annual report and payment for S. N. Marine Marketing, Inc for reinstatement as a FL Corporation.

When we filed our 1995 FL Corporate Report, I sent a letter along advising you that my husband and I had moved to Virginia. I also advised you to show Mr. Brian Pearlman of Tampa, FL as our new registered agent. That report was filed in early July of 1995, late due to our move in April to Virginia. Due to this relocation 1996 was a very hectic year and I did not realize that we had never received your notice for 1996. As I was going thru some files, it did occur to me that I did not have 1996 or 1997 forms. I called our FL agent, assuming he had been receiving and handling them. Brian advised me he had not received either year. When we called your office, we were notified that in September of 1996 you had dissolved the corporation, due to non payment of 1996 annual report without any notification to S. N. Marine Marketing Inc or to any listed officers of the corporation. When I spoke with you, Ms Sellers, you showed nothing on file with our change of mailing address and new registered agent. This was our first indication that S.N Marine Marketing Inc. was dissolved by the state of Florida. All tax filings and obligations have continued to be processed under S.N. Marine Marketing Inc. for 1996 and 1997 and all payments due have been paid under this name. Thank you for your consideration in this matter.
