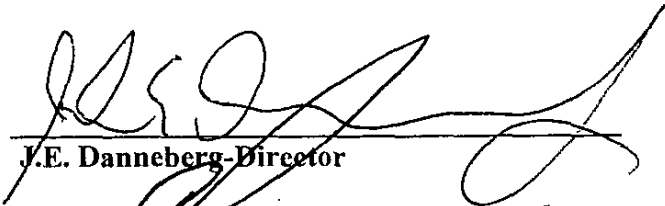
**WRITTEN RESOLUTION OF CSS GROUP INC.
