

AMENDMENT TO ARTICLES OF INCORPORATION OF ENVIRONMENTAL INCOME, INC.

Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of ENVIRONMENTAL INCOME, INC. are hereby amended as follows:

1. Article II is hereby amended to read as follows:

ARTICLE II

NATURE OF BUSINESS
