The undersigned, as President of APARTMENT & RENTAL PROPERTY PRO'S, INCORPORATED, a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act (the "ACT"), states as follows:

1. The current name of the Corporation is APARTMENT & RENTAL PROPERTY PRO'S, INCORPORATED.

2. The date of the filing of the original Articles of Incorporation of the Corporation was Sept. 25, 1990.

3. The Articles of Incorporation of the Corporation are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I - NAME

The name of this corporation is CORONADO REAL ESTATE, INC.

4. The amendment to the Articles of Incorporation of the Corporation was approved by an Action of the Board of Directors and Shareholders on September 8, 1997.
