**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
CORONADO REAL ESTATE, INC.**

The undersigned, as President of CORONADO REAL ESTATE, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act (the "ACT"), states as follows:

1. The current name of the Corporation is CORONADO REAL ESTATE, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation was September 25, 1990 ("Articles of Incorporation"). An Amendment to the Articles of Incorporation was filed on September 10, 1997 ("Amendment to Articles"). The Articles of Incorporation and the Amendment to Articles are hereinafter collectively referred to as "Articles of Incorporation".
3. The Articles of Incorporation of the Corporation are amended by deleting Article 1 entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I - NAME

The name of this corporation is HOUSING TRUST GROUP OF CENTRAL FLORIDA, INC.

4. The amendment to the Articles of Incorporation of the Corporation was approved by a Shareholders' and Directors' Action by Written Consent in Lieu of Special Meeting dated as of the 20th day of July, 2001.
