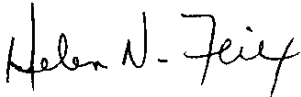
As the accountants for the above named taxpayer, we have been asked to respond to your notice (see enclosed), wherein you advise our client of additional fees to file the annual report.
