Article I of the Corporation's Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE I - Name

The name of the Corporation shall be Segars Properties, Inc.  
with its principal place of business at 4512 S.E. 6th Place,  
Ocala, Marion County, Florida 34471."
