Pursuant to Section 607.1401 of the Business Corporation Act of Florida, the undersigned Corporation adopts these Articles of Dissolution.

FIRST: The name of the Corporation is: K & T.J.'s 27th Avenue Tire Center, Inc., located at: 11509 N.W. 27th Avenue, Miami, Florida 33167.

SECOND: The Corporation's articles of incorporation were filed on October 16, 1990.

THIRD: None of the shares of the Corporation have been issued.

FOURTH: The Corporation has no unpaid debts.

FIFTH: The director and the original incorporator (there were only two men running the corporation), have both authorized the dissolution of the Corporation. The original incorporator, Mr. Theophilus Jones, had previously sent out letters to all corporate creditors to inform them that he longer had anything to do with K & T.J.'s 27th Avenue Tire Center, Inc. Mr. Jones had abandoned the Corporation on or about June 1996, leaving Mr. Kenwin Seepersad as the sole remaining director in charge of the Corporation.


