

WHEREAS, the Corporation amended its Articles of Incorporation on February 12, 1998, to change its name to Miller Cleaning Services, Inc.; and



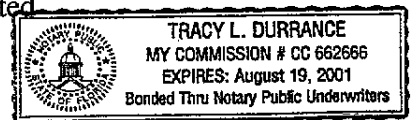
