1. Article I of the Articles of Incorporation of Christopher J. MacQuarrie, P.A. is hereby amended so as to read as follows:


ARTICLE I. NAME

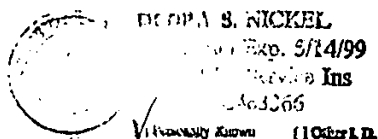
