FIRST: The name of the corporation is Kimzlar, Inc.

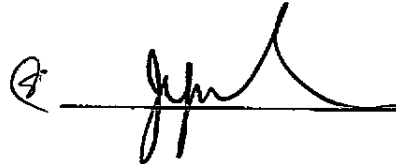
SECOND: The date dissolution was authorized: December 12, 2001.
