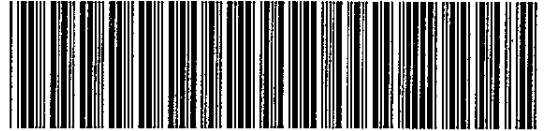



Dissolution was approved by the sole shareholder. The number of votes cast for dissolution was 100% and therefore sufficient for approval.


