**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
NORTH AMERICAN INSURANCE CONSULTANTS, INC.**

Pursuant to Sections 607.1001 and 607.1006 of the Florida Business Corporation Act, NORTH AMERICAN INSURANCE CONSULTANTS, INC., a Florida corporation (corporate document number S08464) (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by amending Article I to read as follows:

ARTICLE I NAME

The name of the Corporation shall be changed, and its new name shall be:

GARRETT CLAIMS GROUP, INC.

2. The foregoing amendment was approved by the sole Stockholder and Director of the Corporation on December 4, 2019. The number of shares of the Corporation's common stock that were voted in favor of the foregoing amendment was sufficient for approval and such shares represent the only group required to vote on the foregoing amendment.
