The shares of stock issued in Boesch Residential Property, Inc. shall be converted into shares, one for one, of the surviving corporation, Voorhees Property Management, Inc.

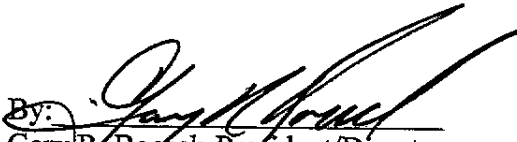

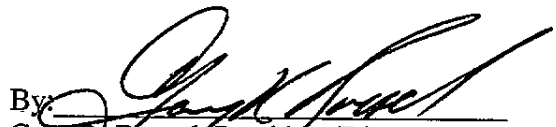
**ARTICLE IV.**
