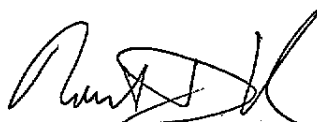

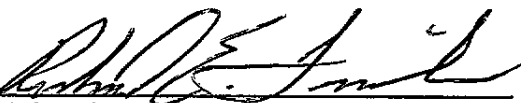
1. Name of Corporation: FISCHER-EVANS & ASSOCIATES, INC.

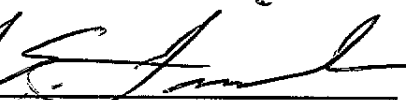
The Articles of Incorporation are amended and the name of the Corporation changed as set forth above.

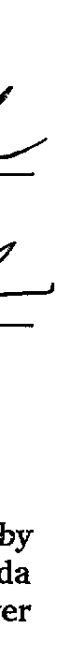
