

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Article IV of the Articles is <u>deleted</u> in its entirety and the following is <u>substituted</u> in its place:

### ARTICLE IV. PURPOSE

The Corporation's business and purpose shall consist solely of the following:

- (a) To own, operate and manage income-producing commercial real estate; and
- (b) To engage in such other lawful activities permitted to corporations by the General Corporation Laws of the State of Florida as are incidental, necessary or appropriate to the foregoing.

**SECOND:** Articles XII and XIII are <u>deleted</u> from the Articles.

**THIRD:** Each of the foregoing amendments were adopted on August 26, 2015.

**FOURTH:** The foregoing amendments were approved by the shareholders. The number of votes case for the amendments was sufficient for approval.
