

Pursuant to my conversation with a representative at the Reinstatement Department yesterday, I am writing to request a waiver of the reinstatement fee on behalf of Ballbusters of Gainesville, Inc. ("the Company"). I have enclosed the Company's reinstatement form and a check for \$300.00 as per your representative's instructions.

The reason that the Company did not timely file its Annual Report is that the Company is in the middle of litigation with one of its three shareholders.
