ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Florida Statute, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is IMAGES GRAPHIC SPECIALTIES, INC.

2. The following Amendment to the Articles of Incorporation was adopted by the Corporation. The Directors of the Corporation manifested such intention by execution of a written statement that such Amendment be adopted, dated the 15TH day of August, 2000. The date of adoption by the shareholders was August 1, 2000.

Article Four of the Articles of Incorporation is amended to read as follows:

FOUR: The aggregate number of shares which the Corporation is authorized to issue is One Million Five Hundred Thousand (1,500,000) shares of common stock.

All or any part of the shares may be issued by the Corporation from time to time and for such consideration as may be determined upon and fixed by the Board of Directors, as provided by law, with due regard to the interest of the existing shareholders; and when such consideration has been received by the Corporation, such shares shall be deemed fully paid.

3. The foregoing Amendment shall become effective and the Articles of Incorporation shall be deemed to be amended thereby upon the filing of these Articles of Amendment by the Department of State.

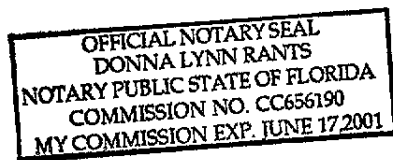
