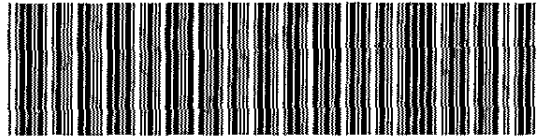

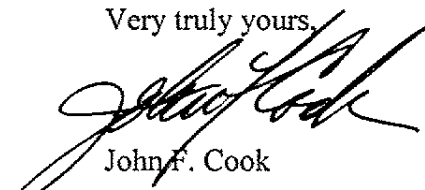

Pursuant to Section 607.1403, Florida Statutes, the undersigned President of TOWER MINI STORAGE, INC. hereby submits these Articles of Dissolution to the Florida Department of State for the purpose of dissolving the corporation.

1. The name of the corporation is TOWER MINI STORAGE, INC.;
2. The date the dissolution was authorized is July 2, 2007 2001, pursuant to a plan of liquidation adopted on May 1, 2007;
3. The dissolution was approved by all of the Shareholders and Directors of the corporation. 100% of the voting stock was cast for dissolution, which was sufficient for approval; and
4. Voting by groups was not required. All of the Shareholders unanimously approved of the dissolution. There is only one voting group entitled to vote, to-wit: common shares.
