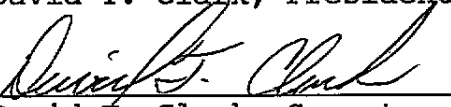
1. Article III of the Articles of Incorporation of NETWORK SUPPLY, INC., is hereby amended as follows:
